## **Test Item:**

Dust test for first characteristic numerals 6

## Atmospheric conditions for water or dust tests:

Air pressure: 86 kPa to 106 kPa
Temperature range: 20℃ to 30℃
Relative humidity: 25 %RH to 75 %RH

**Test samples:** 

Clean and new sample were be tested

## **Test Mothod:**

The test is made using a dust chamber incorporating the basic principles shown in figure 2 whereby the powder circulation pump may be replaced by other means suitable to maintain the talcum powder in suspension in a closed test chamber. The talcum powder used shall be able to pass through a square-meshed sieve the nominal wire diameter of which is 50 um and the nominal width of a gap between wires 75 um. The amount of talcum powder to be used is 2 kg per cubic metre of the test chamber volume. It shall not have been used for more than 20 tests.

## ■ Category 1 enclosures:

The enclosure under test is supported inside the test chamber and the pressure inside the enclosure is maintained below the surrounding atmospheric pressure by a vacuum pump. The suction connection shall be made to a hole specially provided for this test. If not otherwise specified in the relevant product standard, this hole shall be in the vicinity of the vulnerable parts If it is impracticable to make a special hole, the suction connection shall be made to the cable inlet hole. If there are other holes (for example, more cable inlet holes or drain-holes) these shall be treated as intended for normal use on site.

The object of the test is to draw into the enclosure, by means of depression, a volume of air 80 times the volume of the sample enclosure tested without exceeding the extraction rate of 60 volumes per hour. In no event shall the depression exceed 2 kPa (20 mbar) on the manometer shown in figure 2.

If an extraction rate of 40 to 60 volumes per hour is obtained the duration of the test is 2 h. If, with a maximum depression of 2 kPa (20 mbar), the extraction rate is less than 40 volumes per hour, the test is continued until 80 volumes have been drawn through, or a period of 8 h has elapsed.

The enclosure under test is supported in its normal operating position inside the test chamber, but is not connected to a vacuum pump. Any drain-hole normally open shall be left open for the duration of the test. The test shall be continued for a period of 8 h



## **Test Mothod:**

The test is made by completely immersing the enclosure in water in its service position as specified by the manufacturer so that the following conditions are satisfied:

- a) the lowest point of enclosures with a height less than 850mm is located 1 000mm below the surface of the water:
- b) the highest point of enclosures with a height equal to or greater than 850mm is located 150mm below the surface of the water:
- c) the duration of the test is 30 min;
- d) the water temperature does not differ from that of the equipment by more than 5 K. However, a modified requirement may be specified in the relevant product standard if the tests are to be made when the equipment is energized and/or its parts in motion.

Unless there is a relevant product standard, the test conditions are subject to agreement between manufacturer and user, but they shall be more severe than those prescribed in 14.2.7 and they shall take account of the condition that the enclosure will be continuously immersed in actual use
